A. Do you think manually filling form and submitting at the MS-CIT center, is time consuming & hectic? Also include a lot of paper work?





Fig.1: Result from users who are feel manual process is hectic or not.

B. The MS-CIT Examination fees is less than what they charge you, mainly they charge for their Maintenance, still would you pay the same fees?




Fig.2: Result from users who are agree with the new fee process.

C. You Are Happy with your Batch Timings




Fig.3: Result from users who are happy or not happy with their batch.

#### V. CONCEPTUAL WORKING SYSTEM


The current process of MS-CIT is like to go and visit the MS-CIT center for registration and attending a lecture. Which is very hectic and time-consuming, to avoid that we will create an online website and mobile application from where people can register themselves, attend a video tutorial and also do their practical's.

The first step is when the people who want to apply for MS-CIT course, they have to do register first on the website or mobile app. People can register themselves on the website and the mobile application with their email id and mobile number. After adding a mobile number or email id, it is verified by the OTP(One Time Password). After verifying email id and mobile number with OTP the users successfully sign is verified up for the MS-CIT website or mobile application and can able to sign in with the mobile number and email id. After login user needs to fill the MS-CIT registration form with their appropriate details like personal details, educational details and most important is preferred language. as you select your preferred language the notes that will provide for you is in the same language as well as the video tutorial also. after filling these details user needs to upload the documents like Aadhar card, education certificates, passport size photos, and signature.

After completing with registration, MKCL verify the documents uploaded by the user and if it is correct then MKCL send mail users to pay the course fees via online payment or DD. Then after payment is successfully done, MKCL send a username and password (on users email id)of the MS-CIT online course, which helps the user to access their MS-CIT account.

On this account, users get a whole schedule of the course as well as the date of the MS-CIT exam list. according to that user can complete their course and fill the examination form. with these schedule users also get the recorded video lectures of MS-CIT course where it is categories in 3 parts. 1) Low:- where it contains all the introduction about computer (physical and software) and some basic software hands-on like Microsoft office and browser. 2) Medium:- where user gets an all information and practical demos of all the software with very well know knowledge 3) high:- where its the last part contains an in-depth knowledge with practical videos. Also, users get a digital book where it contains all the chapters which included in the videos. it is in .pdf format so can access in any smartphone as well as a computer device. if anyone doesn't know about how to open this pdf file, related this video is also available on the website on the mobile app. This also provides an online practical session for the users. For practicals user need a computer for practice. If the user is done with their any one of them chapter video tutorials, then related to that tutorial practical session is unlock and the user can do their practice on the website. if the user is having any confusion regarding their practical then they can go back and refer their lessons video tutorial. On the basis of this practical session, there are different task are available, where user can perform the task and on the result of that test they can test them self. This task will help the user to prepare for the final test which is conducted by the MKCL. Due to this the chances of passing of users increase.

After completing all tutorial and practical user can select their exam date. from the exam dates list, the user gets all the dates of examination and according to that user can select a seat and slot for the examination.it is mandatory that user can select the exam

dates before 1 month of the exam. the user's examination hall ticket is directly available in their account, also send on users email id.users can print this hall ticket or can show a mobile hall ticket to the examination center at the time of exam.users need to visit the examination center as printed on the hall ticket for the final test.

From above we can say this process is better than the current process in terms of convenience.

The course charges(fees) is less than the current scenario because MKCL don't charge a maintenance cost because they don't provide a computer system like other private computer institute certified by MKCL.so here MKCL only charge for their examination fees and some other taxes which is less than a private technical institute charges. so the current process is also a cost-efficient.

Now, every tutorial is in a video format so the user can understand in a better way and if they found any difficulty so they can go back and watch a video again. if they confused then there are a chat section is present on the website as well as the mobile app also a 24\*7 online helpline number where give you proper guidance. from above we can say the current process is easy to use also where every age group of people can learn from here as their preferred language.

From this solution there are need to clear some points in depth, that clarification has done below in a question-answer format.
