However building a good quality face model is still a challenging task and often requires manual editing to have a realistic model.

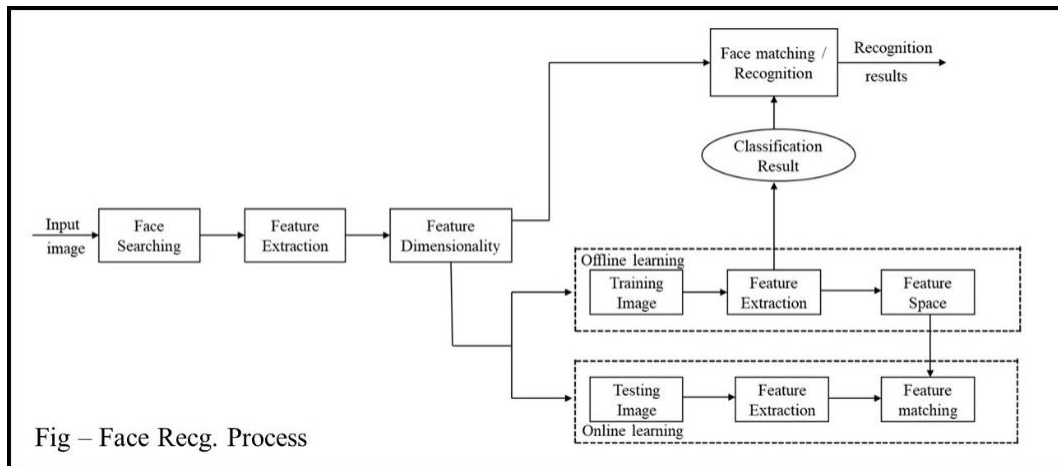


Fig- Flow Chart

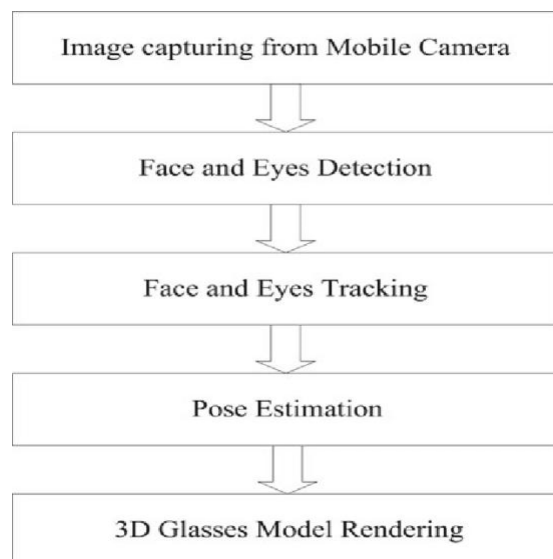
A. Features
