The Souharda Federal Co-operative is a democratically elected self-regulatory organization of the co-operatives registered under Karnataka SouhardaSahakari Act (KSSA) 1997. The present study focused on the Growth trends of Karnataka State Souharda Federal Co-operative Limited, Various Functions of KSSFCL. It is entrusted with the responsible work of supervision by issuing statutory guidelines, for the better working of the Souharda Co-operatives in Karnataka State. The KSSFCL is a facilitating E- Stamping business by Souharda Co-operatives. The activity that is first of its kind in India is a unique achievement of the Federal Co-operative. The present study was covered by 2000-01 to 2015-16 (15 years).*

The formation of Karnataka State Souharda Federal Co-operative Limited (KSSFCL), under the direction of the Karnataka SouhardaSahakari Act (1997), has been a unique feature in the Indian Co-operative Movement. KSSFCL is a member based organization with statutory functions but with an elected body to govern. The Souharda Co-operative get registered the Membership to this Federal Co-operative is automatic along with registration and there is no need for a separate application for membership to KSSFCL. The conventional system of a ' Federation' with Voluntary membership of co-operatives has not been successful on many dimensions, whereas souharda co-operatives getting directly nurtured under ' Federal Structure' has been a successful experiment and it has been replicated already in 13 States on India. The Souharda Co-operatives enjoy functional autonomy in design and implementation of their business plans, customer service activities etc. Unlike other forms of Co-operatives in India the interference of State /Central Governments in the day – to- day operations of Souharda Co-operatives is very minimal. The KSSFCL is successfully working through its one Head office at Bangalore and four Divisional offices at Belgaum, Gulbarga, Bangalore and Mysore for effective administration and professional management of its member co-operatives.

- 7) Supervising proper conduct of audit, general body meetings and election for board of directors and office bearers,
- 8) To undertaking all essential activities for promotion and development of souharda co-operatives.
- 9) Conducting the state, national and International level study tour for co-operative directors, executives and staff.
- 10) Conducting and or participating, in various state, national and International level workshops, seminars and symposia.

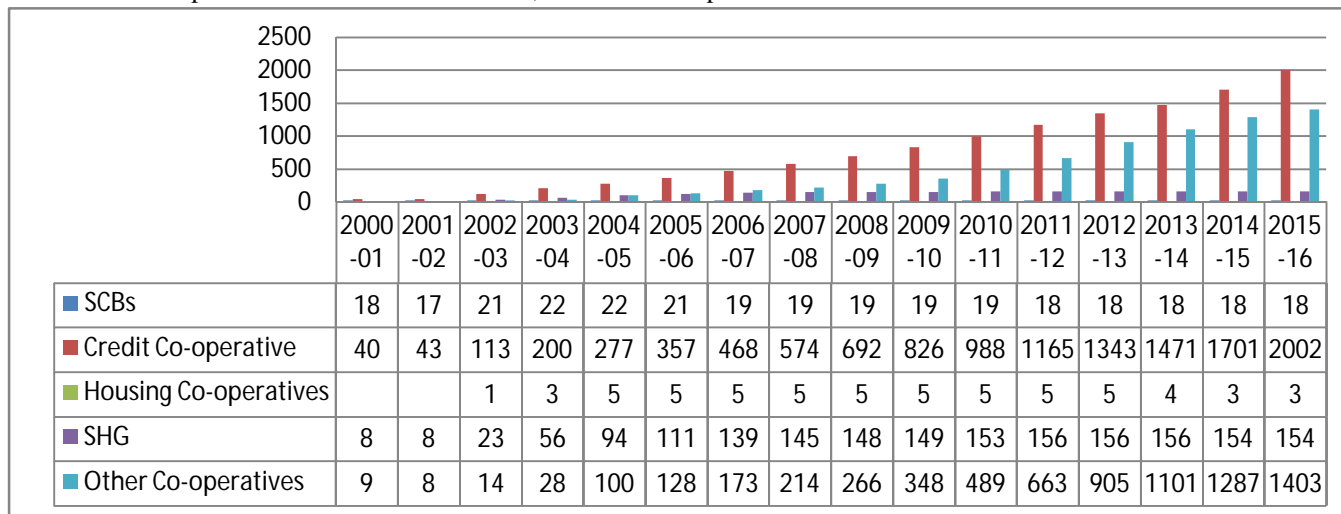
